# **Election Notification**

## **Association Body includes:**

- 1. President
- 2. Vice president
- 3. General Secretary
- 4. Joint Secretary
- 5. Treasurer
- 6. PRO
- 7. Executive members

#### **Election Process:**

- 1. Issuing Notification
- 2. Inviting nominations from eligible category of Alumni
- 3. Submission of nominations to RO within the Date specified
- 4. Withdrawal of nominations
- 5. Date of elections
- 6. Announcement of results
- 7. Oath of elected members by RO

Schedule for Elections: Dates and mode of election will announce it later.

### Nominations are invited for the below following positions:

### **President** (1 position)

- Any member of the association is eligible to file nomination
- Candidate should be proposed by at least '5' members of the association to file the nomination

### **Vice-President** (1 position)

- Any member of the association is eligible to file nomination
- Candidate should be proposed by at least '5' members of the association to file the nomination

### **General Secretary** (1 position)

- Any member of the association is eligible to file nomination
- Candidate should be proposed by at least '5' members of the association to file the nomination

# **Joint Secretary** (1 position)

- Any member of the association is eligible to file nomination
- Candidate should be proposed by at least '5' members of the association to file the nomination

# **Treasurer** (1 position)

- Any member of the association is eligible to file nomination
- Candidate should be proposed by at least '5' members of the association to file the nomination

# **Public Relations Officer** (1 position)

- Any member of the association is eligible to file nomination
- Candidate should be proposed by at least '5' members of the association to file the nomination

#### **Executive Members:**

- Elections will not be conducted for Executive members.
- Members should be nominated by the elected body of the association

### **General rules for Elections**

- 1. Eligible Alumni (only registered alumni in www.rgubaa.in) of RGUKT-Basar will be the **members** of the association and they may franchise their Vote in Elections.
- 2. Tenure of all the Body members would be TWO (02) Years.
- 3. Once the nominations are finalized, voters list will be sent to all the eligible alumni for voting. Corrections in the voter's list (i.e. addition of new appointees / deletion of any), will be accepted till 2 days before the election date. Recurring entries of name(s), if any, shall not be entitled to additional vote.
- 4. Each nomination should be proposed by at least '5' members of the association. Same member cannot propose multiple candidates for the same position.
- 5. One candidate can file nomination for ONLY ONE POSITION.
- 6. Incomplete nominations papers will be rejected. Any overwriting on the nomination paper should be initialed by the candidate before its submission else the nomination paper will be rejected.
- 7. Any candidate may withdraw his / her candidature by the date as indicated in the election schedule in writing to the Returning Officer.
- 8. The final list of the valid nomination(s) shall be notified by the Returning Officer after the last date of withdrawal of nominations.
- 9. After withdrawal of nominations, if more than one nomination is filed for any post of the Association, election for that post will be held as per schedule. However, if the number of valid nominations does not exceed ONE for any post of the Association, the candidates so nominated shall be declared duly elected to that post.
- 10. Each voter can cast a maximum of one vote each for President, Vice-President, General Secretary, Joint Secretary, Treasurer and PRO.
- 11. Every voter is required to produce his / her alumni ID card (I-Card issued by the RGUBAA) at the time of casting his / her vote failing which they will not be permitted to cast their vote.

- 12. Canvassing for votes on grounds of caste, creed, region, religion, community or language is strictly prohibited.
- 13. Persons whose name does not figure in the final Voters List should not be involved in canvassing and other election activities by the candidates.
- 14. Violation of any of the notified rules may lead to cancellation of the candidature.
- 15. If nominations are not received for any position, re-election shall be conducted for the vacant position.
- 16. In case of any TIE between the candidates, TIE will be resolved by tossing a coin.
- 17. Returning officer shall collect the bye laws of the association from the previous office bearers for circulation among the eligible members.
- 18. All rights of decision / interpretation or clarification of the foregoing shall vest in the Returning Officer whose decision shall be final.
